#### 1. Ratification of Revised Bylaws

President Dan Rather began by acknowledging and thanking the committee assigned to review the 2017 Rules & Regulations, Karen Keto, Elisa McArthur and Linda Voorhees. The final version presented to the membership was a culmination of efforts by the Board and the appointed committee. After confirming that membership attendance exceeded the required quorum, Dan Rather called for a vote in favor of the revised bylaws as posted on the website. By show of hands, the revised bylaws were approved as written. Dan Rather announced that the revised bylaws are now our current bylaws.

## 2. Election of Officers

The meeting was turned over to Mary Dugan, nominating committee. Mary introduced the four candidates: Louis Sette running for President, Sandra Van Slyke/Vice President, Evelyn Cesarotti/Treasurer, Cyndi Donimari/Secretary. Each candidate spoke briefly about their background/skill set, club participation and vision for the club's future. Following the introductions, Dan Rather called for nominations from the floor. No one came forward. Second call with no response. Dan Rather declared nomination closed. Ballots collected. Results tabulated by Mary Dugan and Norris Bryant. The four nominees, Louis Sette, Sandra Van Slyke, Evelyn Cesarotti, and Cyndi Donimari were elected to serve as the Executive Board for the 2022 calendar year. The newly elected officers were sworn in. Dan Rather thanked them for volunteering to serve on the Board and encouraged all members to volunteer in various capacities, i.e., monitor, committee chair positions. He recognized the current Board, commented that the existing Board has bonded and worked well together, and hopes the newly appointed Board can do as well in terms of discussion and compromise.
